He wrote the monographs *Broken Hegemonies* (Indiana University Press, 2003) and *Heidegger on Being and Acting: From Principles to Anarchy* (Indiana University Press, 1987), as well as a semi-autobiographical book, *Origins* (Diaphanes, 2016). He translated and wrote a commentary on a number of Meister Eckhart's sermons, published as *Wandering Joy: Meister Eckhart's Mystical Philosophy* (Lindisfarne, 2001). He also was the author of several articles, including "Trois penseurs du délaissement: Maître Eckhart, Heidegger, Suzuki," published in two parts in *Journal of the History of Philosophy* (1974–75), and "La différence symbolique," *Cahiers internationaux de symbolisme* (1972).

Rosemary Twomey is Assistant Professor of Philosophy at Queens College, City University of New York.
