August 4–10, 2013, the XXIII World Congress of Philosophy took place in Athens. The Leibniz Society organized the following events:

NEWS FROM THE LEIBNIZ-GESELLSCHAFT

On May 31/June 1, 2013, on invitation by the Leibniz Society and the Leibniz Endowed Professorship, a meeting of the presidents of Leibniz associations took place in Hanover (Leibnizhaus). Concha Roldán (Madrid), Kiyoshi Sakai (Tokyo), Donald Rutherford (California), Enrico Pasini (Turin), Marcelo Dascal (Tel Aviv), Michel Fichant (Paris/Strasbourg), Herbert Breger (Hanover), Hans Poser (Berlin), Rolf Wernstedt (Hanover), and Wenchao Li (Hanover/Potsdam) took part in this meeting. The two-day meeting was concerned with the preparation of cooperative events within the scope of the X International Leibniz Congress which will take place on July 18–23, 2016 in Hanover. Furthermore, it addressed the promotion of worldwide Leibniz research and the intensification of international cooperation.

VGH Award for excellent PhD Theses on Leibniz

At the Leibniz Society's suggestion the VGH Insurance endowed a prize for excellent PhD Theses on Leibniz. The prize can be awarded every five years during the International Leibniz Congresses. It is planned to award the prize for the first time in the context of the upcoming Congress in 2016. The target audience is doctoral candidates from all over the world focusing on Leibniz. Specific guidelines are being prepared.
