Thomas C. Anderson is professor and chair of the Philosophy Department at Marquette University. He is author of *The Foundation and Structure of Sartrean Ethics* (University of Kansas Press, 1979) and numerous articles on Marcel, Sartre, de Beauvoir, and questions of ethics and religion.

Linda Bell is professor of philosophy at Georgia State University. She is author of *A Sartrean Ethics of Authenticity* (University of Alabama Press, 1989). She contributed to the 1983 SPEP/SUNY volume *Phenomenology in a Pluralistic Context*, edited by William McBride and Calvin Schrag.

Susan Bordo is assistant professor of philosophy at Le Moyne College. She is author of *The Flight to Objectivity: Essays on Cartesianism and Culture* (SUNY Press, 1987) and coeditor (with Alison Jaggar) of *Gender/Body/Knowledge: Feminist Reconstructions of Being and Knowing* (Rutgers University Press, 1988). She has also contributed to *Soundings, Signs*, and *The Philosophical Forum*.

Elizabeth A. Bowman is visiting assistant professor of French at Middlebury College. She taught previously at Memphis State University after completing her doctorate at Columbia University on "The Moral Impasse and the Possibility of the Human: A Study of Jean-Paul Sartre's Ethics and his Political Theater" (1987). She has also coauthored a paper on Sartre's dialectical ethics with Robert V. Stone for *Social Text*.

Martin Dillon is professor of philosophy at the State University of New York at Binghamton. He is author of *Merleau-Ponty's Ontology* (Indiana University Press, 1987) and has written numerous articles on Merleau-Ponty, Nietzsche, Sartre, Kant, and topics in phenomenological psychology, philosophy and literature, and existential thought.

Martin Donougho is assistant professor of philosophy at the University of South Carolina. He has written a variety of articles for such journals as *Philosophy and Social Criticism*, *Hegel-Studien*, *Clio*, *Post Script*, *The Journal of Aesthetic Education*, and the *Alaska Quarterly Review*.

C. Stephen Evans is professor of philosophy and curator of the Howard and Edna Hong Kierkegaard Library at St. Olaf College in Northfield, Minnesota. He has

written a number of books, including *The Quest for Faith: Reason and Mystery as Pointers to God* (1986), *Philosophy of Religion: Thinking About Faith* (1985), *Kierkegaard's 'Fragments' and 'Postscript': The Philosophy of Johannes Climacus* (Humanities Press, 1983), and *Preserving the Person: A Look at the Human Sciences* (1977).

Wayne Froman is associate professor of philosophy at George Mason University. He is author of *Merleau-Ponty: Language and the Act of Speech* (Bucknell University Press, 1982) and of a variety of articles in continental philosophy.

Dick Howard is professor of philosophy at the State University of New York at Stony Brook and senior fellow at the Research Institute on International Change at Columbia University. He has written a number of books including a second edition of his 1977 *The Marxian Legacy* (University of Minnesota Press, 1988), *From Marx to Kant* (1985), *La naissance de la pensée politique américaine* (1987), and *Defining the Political* (University of Minnesota Press, 1988), and *The Politics of Critique* (University of Minnesota Press, 1988).

Eleanor H. Kuykendall is associate professor and chair of philosophy at the State University of New York College at New Paltz. She is also coordinator of the Linguistics Program there. Editor of *Philosophy in the Age of Crisis* (1970), she is author of articles on Sartre, Irigaray, and feminist linguistics.

Claude Lefort is director of Studies at the Ecole des Hautes Etudes en Sciences Sociales in Paris. He is author of many books including a series of essays on Merleau-Ponty entitled *Sur une colonne absente*, *Le Travail de l'oeuvre Machiavel*, *The Forms of History*. He is one of the most important political philosophers writing in France today.

John McCumber is associate professor of philosophy at Northwestern University. Author of numerous articles in continental philosophy, especially concerning Hegel, Heidegger, and Habermas, his book *Poetic Interaction* appeared with University of Chicago Press in 1989.

Christie McDonald is professor in the Department of French at the University of Montreal. She has written *The Extravagant Shepherd*, *The Dialogue of Writing*, and *Dispositions*.

John M. Michelsen is associate professor of philosophy at the University of Victoria. He has written articles on Santayana, Plato, and Kierkegaard in *Transactions of the Charles S. Peirce Society*, *Diotima*, and *Analecta Husserliana*.

Patricia J. Mills is associate professor of political theory in the department of political science at the University of Massachusetts at Amherst. Author of *Woman, Nature, and Psyche* (Yale University Press, 1988), she has also written on marginality and otherness, the "woman question," motherhood, and Hegel.

Claude Piché is professor agrégé in the Department of Philosophy at the University of Montreal. Author of *Das Ideal, ein Problem der Kantischen Ideenlehre* (Bouvier, 1984), he has also published articles on Husserl, Heidegger, Kant, Habermas, aesthetic experience, and hermeneutics.

Jo-Ann Pilardi is assistant professor of philosophy and women's studies at Towson State University. She has written on Simone de Beauvoir in *Feminist Studies* and in *History of Women Philosophers*, and on Hegel, Freud, and feminist studies in *Hypatia*.

Gary Shapiro is professor of philosophy at the University of Kansas and a member of the Executive Committee of the International Association for Philosophy and Literature and program committee member of the American Society for Aesthetics. He edited the volume *Hermeneutics: Question and Prospects* with Alan Sica (University of Massachusetts Press) and his book on Nietzsche is forthcoming Indiana University Press.

Joan Stambaugh is professor of philosophy at Hunter College of the City University of New York. She is translator of various texts by Heidegger (including *The End of Philosophy, Identity and Difference*, and *Schelling*), and author of *Untersuchungen zum Problem der Zeit bei Nietzsche* (Nijhoff, 1959) and *Nietzsche's Thought of Eternal Return* (Johns Hopkins University Press, 1972).

Robert V. Stone is associate professor of philosophy at the C. W. Post Center of Long Island University. He is author of various papers on Sartre's ethics including *Social Text* and the *Revue Internationale de Philosophie* and is translator of Francis Jeanson's *Sartre and the Problem of Morality* (Indiana University Press, 1980). He has also contributed to *The Philosophy of Jean-Paul Sartre* (Schilpp Library of Living Philosophers) and *Explorations in Phenomenology* (Nijhoff).

Gianni Vattimo is professor of theoretical philosophy at the University of Torino, where he has also held the position of chair of the Faculty of Letters and Philosophy. He has been visiting professor at SUNY/Albany, Yale, and NYU. Editor of *Rivista di Estetica*, he has written over a dozen books, including *The End of Modernity* (Johns Hopkins University Press, 1989). His other books focus on Aristotle, Heidegger, Nietzsche, Schleiermacher, and his own notion of weak thought.

Bernhard Waldenfels is professor of philosophy at the Ruhr-University Bochum, West Germany. His books include *Das sokratische Fragen. Aporie, Elenchos, Anamnesis* (Hain, 1961), *Das zwischenreich des Dialogs. Sozialphilosophische Untersuchungen in Anschluss an E. Husserl* (Nijhoff, 1971), *Der Spielraum des Verhaltens* (Suhrkamp, 1980), *Phänomenologie in Frankreich* (Suhrkamp, 1985), and *Ordnung im Zwielicht* (Suhrkamp, 1987).

Merold Westphal is professor of philosophy at Fordham University. He is author of *History and Truth in Hegel's Phenomenology* (Humanities, 1979), *God, Guilt, and Death: An Existential Phenomenology of Religion* (Indiana University Press, 1984), and *Kierkegaard's Critique of Reason and Society* (Mercer, 1987).

Terry Winant is assistant professor of philosophy at the California State University at Fresno. She taught previously at the University of Wisconsin—Madison. She has written "How Ordinary (Sexist) Discourse Resists Radical (Feminist) Critique" and "The Feminist Standpoint: A Matter of Language" in *Hypatia: A Journal of Feminist Philosophy*, and an article on Sartre in the *Southern Journal of Philosophy*.

David Wood is senior lecturer in philosophy and programme director of the Centre for Research in Philosophy and Literature at the University of Warwick. He is author of *The Deconstruction of Time* (Humanities, 1989) and *Philosophy at the Limit* (Unwin Hyman, 1990). He is also coeditor of various books including *Heidegger and Language* (1981), *Time and Metaphysics* (1982), *Derrida and Difference* (1988), *Exceedingly Nietzsche* (1988), and *The Provocation of Lévinas* (1988).
