LINDA MARTÍN ALCOFF teaches philosophy and women's studies at Syracuse University. She is the author of *Real Knowing: New Versions of the Coherence Theory* (Cornell, 1996), co-editor of *Feminist Epistemologies* (Routledge, 1993), and editor of *Epistemology: The Big Questions* (Blackwell, forthcoming). She has published in *SIGNS*, *Cultural Critique*, *Philosophical Forum*, *Hypatia*, and other journals. Her next book project is *Visible Identities: Race, Gender, and the Self*.

ELLEN T. ARMOUR is associate professor in the department of religious studies at Rhodes College in Memphis, Tennessee. Her most recent publication is "Crossing the Boundaries Between Deconstruction, Feminism and Religion" in *Feminist Interpretations of Derrida* (Penn State Press, 1997). Her book manuscript, *Deconstruction, Feminist Theology and the Problem of Difference: Subverting the Race/Gender Divide*, is currently under review for publication.

MARY CATHARINE BASEHEART, scd, died on November 25, 1994. She was Distinguished University Professor at Spalding University, where she also had served as Dean for eighteen years. Dr. Baseheart was the author of *Person in the World, Introduction to the Philosophy of Edith Stein*, which was published posthumously in 1997 by Kluwer Academic Publishers. She published numerous articles and lectured widely on Stein's philosophy, both in the United States and abroad. In 1990, she founded the *Edith Stein's Center for Study and Research* at Spalding University. At the time of her death, she was completing a translation of Stein's *Beitrage zur philosophischen Begrundung der Psychologie und der Geisteswissenschaften*,

to be included in the *Collected Works of Edith Stein*, published by the International Carmelite Studies.

R. PHILIP BUCKLEY is associate professor in the department of philosophy at McGill University, Montreal, Canada. He is the author of *Husserl, Heidegger, and the Crisis of Philosophical Responsibility* (Kluwer, 1992) and numerous articles on phenomenological analyses of the self and on political philosophy. He has just finished translating a volume of Husserl's *Essays on Culture* to appear in the Series *Edmund Husserl: Collected Works* (Kluwer).

JOHN CARVALHO is associate professor of philosophy at Villanova University. He is the author of essays on Nietzsche, Merleau-Ponty, and Foucault, and he is completing a book of essays on the visual arts and contemporary critical theory tentatively titled *Aesthetics of the Visible*.

FABIO CIARAMELLI is professor of philosophy at the Federico II University of Naples. He is the author of *Transcendance et étique. Essai sur Levinas* (Bruxelles, Ousia, 1989) and with B. Moroncini and F. C. Papparo, *Diffrazioni. La filosofia alla prova della psicoanalisi* (Milan, Guerini, 1994) as well as several articles on contemporary continental philosophy.

JACK DOODY is professor of philosophy at Villanova University. He has published previously on Habermas in *International Philosophical Quarterly* and *American Catholic Philosophical Quarterly*.

LAWRENCE HASS is associate professor of philosophy at Muhlenberg College in Allentown, Pennsylvania. He is co-editor (with Dorothea Olkowski) of *Re-Reading Merleau-Ponty: Essays Beyond the Continental-Analytic Divide*, forthcoming from Humanities Press, 1999. He has published essays on a variety of figures and topics in twentieth century continental philosophy. He is currently writing a book on Merleau-Ponty's epistemology.

LAWRENCE J. HATAB is professor of philosophy at Old Dominion University. He is the author of *Myth and Philosophy* (Open Court, 1990) and *A Nietzschean Defense of Democracy* (Open Court, 1995), a book that developed out of the essay presented in this volume. He has also published numerous articles on Nietzsche and Heidegger.

STEVEN HENDLEY is associate professor of philosophy at Birmingham-Southern College. He is the author of *Reason and Relativism: A Sartrean*

*Investigation* (SUNY Press, 1991) and several articles on issues in moral-political philosophy and social theory, especially from a continental perspective. Most recently, he has published "From Communicative Action to the Face of the Other: Habermas and Levinas on the Foundations of Moral Theory" (*Philosophy Today*, 1996).

NANCY J. HOLLAND is chair of the department of philosophy and coordinator of the women's studies program at Hamline University. She is the author of *Is Women's Philosophy Possible?* (Rowman and Littlefield, 1990) and editor of *Feminist Interpretations of Jacques Derrida* (Penn State Press, 1997), and has also published many articles in both continental philosophy and feminist thought. Her most recent book is *The Madwoman's Reason: The Concept of the Appropriate in Ethical Thought* (forthcoming from Penn State Press).

AXEL HONNETH is a professor of social philosophy at the Johann Wolfgang Goethe University in Frankfurt/Main. His main publications include *Social Action and Human Nature* (Cambridge University Press, 1988); *Critique of Power* (MIT Press, 1990); *The Struggle for Recognition* (Polity-Press, 1994); "The Fragmented World of the Social" in *Essays in Social and Political Philosophy* (SUNY Press, 1995).

LENORE LANGSDORF is a professor of the philosophy of communication at Southern Illinois University in Carbondale, who teaches and writes in the areas of hermeneutic phenomenology, American pragmatism, and the philosophy of social science. She has published many articles and is co-editor of and contributor to several books, the most recent of which is *Recovering Pragmatism's Voice: The Classical Tradition, Rorty, and the Philosophy of Communication* (published by SUNY Press in 1995). She is also co-editor of *Human Studies: A Journal for Philosophy and the Social Sciences*, and editor of the *SUNY Series in Philosophy of the Social Sciences*.

JIM MARSH is a professor of philosophy at Fordham University who teaches and writes in the areas of phenomenology, hermeneutics, critical theory, Hegel, and Marx. He has published over fifty articles and five books, the most recent being *Post-Cartesian Meditations* (1988), *Critique, Action, and Liberation* (published by SUNY Press in 1994) and *Process, Praxis, and Transcendence* (to be published by SUNY Press in 1999).

MARTIN J. BECK MATUŠTÍK is associate professor of philosophy at Purdue University. He is the author of *Postnational Identity: Critical Theory and Existential Philosophy in Habermas, Kierkegaard, and Havel* (Guilford Press,

1993); *Specters of Liberation: Great Refusals in the New World Order* (SUNY Press, 1998); and co-editor with Merold Westphal of *Keirkegaard in Post/Modernity* (Indiana UP, 1995).

PATRICK F. MCKINLAY is assistant professor of political science in the Department of History, Indian Studies, and Political Science at Morningside College in Sioux City, Iowa. He has published an article, "Postmodernism and Democracy: Learning from Lyotard and Lefort," in the *Journal of Politics* (forthcoming). His recent research focuses on the implications of continental theory (Gadamer, Habermas, Lyotard, and Arendt) and democratic theory.

MICHAEL MURRAY is James Taylor Monroe Professor of Philosophy at Vassar College. He is the author of *Modern Philosophy of History, Modern Critical Theory, Hermeneutics, Deconstruction, and the Great Wall of China* and editor of *Heidegger and Modern Philosophy*. Recent essays include ones on Derrida and Heidegger, Hegel and Holderlin.

DAVID M. RASMUSSEN is a professor in the department of philosophy at Boston College. He is Founder and Editor-in-Chief of *Philosophy and Social Criticism* (1978–), the *Philosophy & Social Criticism Book Series* (1995–), and *Cultural Hermeneutics* (1973–7). He is author of *Reading Habermas* (1990), *Symbol and Interpretation* (1974) and *Mythic-Symbolic Language and Philosophical Anthropology* (1971). He is editor of several books including *Universalism vs. Communitarism* (1990) and most recently *The Handbook of Critical Theory* (1996).

MARGARET A. SIMONS, professor of philosophy and coordinator of women's studies at Southern Illinois University at Edwardsville, is co-editor, with Azizah al-Hibri, of *Hypatia Reborn: Essays in Feminist Philosophy* (Indiana, 1990) and editor of *Feminist Interpretations of Simone de Beauvoir* (Penn State, 1995). She has recently completed a book, *Feminism, Race, and the Origins of Existentialism: Simone de Beauvoir's 'The Second Sex'*; and is currently co-editing, with Sylvie Le Bon de Beauvoir, *The Beauvoir Series* for Indiana University Press.

STEPHEN H. WATSON is professor and chair of the Department of Philosophy at the University of Notre Dame. He is the author of *Extensions: Essays on Interpretation, Rationality, and the Closure of Modernism* (Albany, SUNY Press, 1992) and *Tradition(s): Refiguring Community and Virtue in Classical German Thought* (Indiana, 1997). In addition to being the author of many articles, he has co-edited two collections on contemporary

continental thought: *Transitions in Continental Philosophy* (Albany: SUNY Press, 1994) and *Phenomenology, Interpretation and Community* (Albany: SUNY Press, 1996).
