Members' Publications and Accomplishments, 2000-2001

Dr. Felix D. Almaraz, Jr., Professor of History, University of Texas at San Antonio, published as a co-author *Cisneros 2000*, an illustrated biography of the pre-eminent Catholic and Borderlands artist Jose Cisneros.

Reverend Robert J. Batule, Corpus Christi Roman Catholic Church and Adjunct Professor, St. John's University, New York, published a Memorial tribute to John Cardinal O'Connor in *Catholic Social Science Review* (2000); "Homilies for December," *Homiletic and Pastoral Review* 51 (November 2000); was selected for inclusion in *Who's Who in the World, 2001*; wrote a Master's level course on Catholic Apologetics for Catholic Distance University; and reviewed Patrick Riley, ed., *Keeping Faith (The Catholic Social Science Review, 2001)*.
