Hadley Arkes is the Edward Ney Professor of Jurisprudence at Amherst College, where he has taught since 1966. His books include *Bureaucracy, the Marshall Plan and the National Interest* (1972), *The Philosopher in the City* (1981), *First Things* (1986), *Beyond the Constitution* (1990), *The Return of George Sutherland* (1994), *Natural Rights and the Right to Choose* (2002), and *Constitutional Illusions and Anchoring Truths: The Touchstone of the Natural Law* (2010). His articles have appeared in professional journals, and he has become known to a wider audience through his writings in the *Wall Street Journal*, the *Weekly Standard*, and *National Review*. He has been a contributor also to *First Things*, a journal that took its name from his book of that title. For eight years he wrote a column for *Crisis* magazine under the title of “Lifewatch,” and he has carried over that concern as one of the band of friends who formed the new web journal *The Catholic Thing*.

Ryan J. Barilleaux is Paul Rejai Professor of Political Science, Miami University, Oxford, Ohio. He is the author or editor of ten books and has published dozens of scholarly articles as well. His latest book is *Tough Times for the President*. He was the Miami University Effective Educator for 2010–2011 and is a former editor of the *Catholic Social Science Review*. He received a B.A., *summa cum laude*, from the University of Louisiana at Lafayette (1979), and an M.A. (1980) and Ph.D. (1983) from the University of Texas at Austin.

Charles Bellinger is associate professor of theology and ethics at Brite Divinity School, Texas Christian University. He is the author of *The Genealogy of Violence: Reflections on Creation, Freedom, and Evil* (Oxford University Press, 2001), *The Trinitarian Self: The Key to the Puzzle of Violence* (Pickwick, 2008), *The Joker Is Satan and So Are We: And Other Essays on Violence and Christian Faith* (Churchyard Books, 2010), and *Jesus v. Abortion: They Know Not What They Do* (Cascade, 2016).

Alexander D. Binder will join the economics faculty at Pittsburg State University in Pittsburg, Kansas, as an assistant professor in August 2016 after two years as a visiting instructor at Franklin & Marshall College in Lancaster, Pennsylvania. He is a doctoral candidate in economics and social science at the University of Missouri-Kansas City and will defend his dissertation in July 2016. His research interests broadly fall under the intersection of moral philosophy and economics, including social and

welfare economics, welfare policy, non-profit networks, Catholic Social Teaching, and money and banking.

Steven J. Brust holds an M.A. in philosophy from Franciscan University of Steubenville, and an M.A. and Ph.D. in political theory from the Catholic University of America. His research and teaching interests include the history of Western political thought, Catholic political thought, Catholic Social Teaching, natural law and natural rights, law and morality, and American government. He has taught at Seattle Pacific University, Catholic University of America, Georgetown University, and Lock Haven University, and is currently assistant professor of political science at Eastern New Mexico University.

Allan Carlson is president emeritus of the Howard Center for Family, Religion & Society, founder of the World Congress of Families, and editor of *The Family in America: A Journal of Public Policy*. He has been Distinguished Visiting Professor of Politics and History at Hillsdale College. President Ronald Reagan appointed him in 1988 to the National Commission on Children, on which he served until 1993. He holds a Ph.D. in Modern European History from Ohio University. His books include, most recently, *The Natural Family Where It Belongs: New Agrarian Essays* (2014) and *Family Cycles: Strength, Decline & Renewal in American Domestic Life, 1630–2000* (2016). His articles have appeared in *The Journal of Social Issues*, *Society*, *Journal of Law, Ethics and Public Policy*, *The San Diego Law Review*, *The Chesterton Review*, *The Public Interest*, *The Washington Post*, *The Wall Street Journal*, and many other periodicals.

Alfred R. D’Anca is associate professor of sociology at the College of Mount Saint Vincent, Riverdale, New York, where he teaches courses in the fields of social diversity, cross-cultural gender violence, and criminology and justice. He received his doctoral degree in sociology from Fordham University, Bronx, New York, and had a career of service in the United States Probation System that included significant interaction with the federal judiciary. His areas of interest include the social dimensions of law, the relationship of crime and deviance to racial/ethnic diversity and the social environment, and the relationship of Catholic social principles to criminological theory and the system of doing justice.

William De Soto is associate professor of political science at Texas State University and is interested in Christianity and public policy.

Her teaching and research center on Catholic social thought, economic justice, liberation theology, and ecological ethics. She is an active member of and has presented at the American Academy of Religion, Catholic Theological Society of America, and College Theology Society. Her latest article is “Moral Imagination and Prophetic Witness: Women Religious Congregations in a World of Globalization” (College Theology Society, Annual Volume 60, 2014). In dialogue with Anselm Academic, she is developing a proposal for a book that puts Catholic social thought and its principles at the service of public policy in the areas of economic justice, immigration, human trafficking, education, women, and health care.

Kieran Flanagan is a senior research fellow at the School of Sociology, Politics and International Studies at the University of Bristol, United Kingdom.
