Gerard V. Bradley is professor of law at the University of Notre Dame and Senior Fellow of the Witherspoon Institute and director of its Center on Religion and the Constitution. He is the author of numerous books and scholarly articles on constitutional law, law and religion, and other topics.

Steven J. Brust is an assistant professor of political science at Eastern New Mexico University where he teaches a variety of courses in American government and political theory. His research interests include natural law and natural rights, church-state relations, and Western political thought. He also has an interest in Catholic social and political teaching, especially as it relates to the American political order and culture.

J. Budziszewski (Ph.D. Yale, 1981) is a professor of government and philosophy at the University of Texas at Austin. His area of specialization is the natural moral law. He has published widely not only in professional journals but also in periodicals of broader readership such as *First Things*. The most recent of his thirteen books are *Commentary on Thomas Aquinas's Virtue Ethics* (Cambridge University Press, 2017), *Commentary on Thomas Aquinas's Treatise on Law* (Cambridge University Press, 2014), and *On the Meaning of Sex* (ISI Books, 2012). The list also includes three books for students, notably *How to Stay Christian in College*, and he maintains a website and blog, *The Underground Thomist*.

Andrew Cummings is a professor of philosophy at Mount Angel Seminary, Oregon. His research centers on the history of ideas, metaphysics, and philosophical theology, with a particular interest in linking contemporary trends in philosophy with trends in medieval thought. He has published on the ontological proof in St. Anselm and Hegel, and has co-authored a book, *Thinking God*, on various topics in the philosophy of religion.

Paul R. DeHart is an associate professor of political science at Texas State University. He holds a Ph.D. from the University of Texas at Austin (2005) and is the author of *Uncovering the Constitution's Moral Design* (University of Missouri Press, 2007) and editor (with Carson Holloway) of *Reason, Revelation, and the Civic Order: Political Philosophy and the Claims of Faith* (Northern Illinois University Press, 2014). His articles have appeared in journals such as *Polity*, *Critical Review*, *Locke Studies*, and *Perspectives on Political Science*.

Kieran Flanagan is a senior research fellow at the School of Sociology, Politics and International Studies at the University of Bristol, United Kingdom. His main publications are *Sociology and Liturgy: Re-presentations of the Holy* (1991); *The Enchantment of Sociology: A Study of Theology and Culture* (1996); *Seen and Unseen: Visual Culture, Sociology and Theology* (2004); and *Sociology in Theology: Reflexivity and Belief* (2007). His latest work is *Sociological Noir: Irruptions and the Darkness of Modernity* (2017). Currently he is working on a companion volume: *The Light of Modernity: A Sociology of Seeking* (forthcoming).

Jerome C. Foss is an associate professor of politics at the Alex G. McKenna School of Business, Economics, and Government, and fellow at the Center for Political and Economic Thought, at Saint Vincent College in Latrobe, Pennsylvania. He holds a Ph.D. and M.A. from Baylor University and a B.A. from the University of Dallas. He is the author of *Constitutional Democracy and Judicial Supremacy: John Rawls and the Transformation*

of *American Politics* (Cambria, 2016), and is currently working on a book about Flannery O'Connor and political thought.

Gary D. Glenn is distinguished teaching professor emeritus of political science at Northern Illinois University, where he has taught since 1966. He is a student of the history of political philosophy, American political thought, and of the relation of religion to both. He has paid particular attention throughout his career to Xenophon, Hobbes, Locke, and the American founding. In recent years, his scholarship has focused primarily on the relation of Catholicism to American democracy.

Carmine Gorga is president of the Somist Institute. He is a former Fulbright scholar and the recipient of a Council of Europe Scholarship for his dissertation on "The Political Thought of Louis D. Brandeis." In a book and a series of papers, he has sought to transform the linear world of economic theory into a relational discipline. The resulting work, *The Economic Process* (2002), reached its third edition in 2016. His current research involves unifying economic theory, policy, and practice (Concordian economics), and he is also integrating this work into political science (Somism) and culture in general (Relationalism).

Kenneth L. Grasso is a professor of political science at Texas State University. He has edited or co-edited several books including *Theology and Public Philosophy* (Lexington, 2012); *Rethinking Rights: Historical, Political and Philosophical Perspectives* (University of Missouri Press, 2008); and *Catholicism and Religious Freedom: Contemporary Reflections on Vatican II's Declaration on Religious Liberty* (Rowman & Littlefield, 2006). He currently serves as first vice-president of the Society of Catholic Social Scientists and is a research associate at the Veritas Center for Ethics in Public Life.

John P. Hittinger is a professor in the department of philosophy and a member of the Center for Thomistic Studies at the University of St Thomas, Houston. Hittinger has published articles on political philosophy, just war theory, and the thought of Karol Wojtyla. He has published six books, including *Liberty, Wisdom and Grace: Thomism and Modern Democratic Theory* (Lexington Press, 2002).

Stephen M. Krason is a professor of political science and legal studies at Franciscan University of Steubenville, Ohio, and co-founder and president of the Society of Catholic Social Scientists.
