

## NOTES ON THE CONTRIBUTORS

**Panayot Butchvarov** is The University of Iowa Foundation Distinguished Professor of Philosophy. His major contributions are in epistemology, ethics, and metaphysics. His books include *Skepticism about the External World* (1998), *Skepticism in Ethics* (1989), or *The Concept of Knowledge* (1970). He is currently working on a book entitled *Antropocentrism in Philosophy*.

**Teodor Dima** is Corresponding Member of the Romanian Academy, and Director of the „Gheorghe Zane” Institute for Economic and Social Research. His main contributions are in epistemology, philosophy of science, and logic. His books include: *Metodele inductive (The Inductive Methods)* (1975), *Intre prudentă și eroare. Eseu asupra naturii și dinamicii științei (Between Prudence and Error. Essay on the Nature and Dynamics of Science)* (1978), *Explicație și înțelegere (Explanation and Understanding)* (vol I. 1980, vol. II 1994), or *Privind înapoi cu deferență (Looking Backwards with Deference)* (2006).

**Catherine Z. Elgin** is Professor of the Philosophy of Education at Harvard Graduate School of Education. Her areas of study include the theory of knowledge, philosophy of art, philosophy of language, and philosophy of science. She is the author of *Between the Absolute and the Arbitrary* (1997), *Considered Judgment* (1996), *Reconceptions* (with Nelson Goodman) (1988), *Esthétique et Connaissance: Pour changer de Sujet* (with Nelson Goodman) (1990), and *With Reference to Reference* (1983).

**Sanford Goldberg** is Professor of Philosophy at Department of Philosophy, Northwestern University. He works in the areas of epistemology and the philosophy of mind and language. His interests in epistemology include such topics as reliabilism, the epistemology of testimony, the internalism/externalism dispute, self-knowledge, and skepticism. He is the author of *Relying on Others* (2010), *Anti-Individualism: Mind and Language, Knowledge and Justification* (2007), and, with Andrew Pessin, of *Gray Matters: An Introduction to the*

*Philosophy of Mind* (1997). He is also the editor of *Internalism and Externalism in Semantics and Epistemology* (2007).

**Susan Haack** is Distinguished Professor in the Humanities, Cooper Senior Scholar in Arts and Sciences, Professor of Philosophy, and Professor of Law at the University of Miami. She is the author of many influential books and articles in epistemology, logic and philosophy of science. Her most recent books include *Evidence and Inquiry: A Pragmatist Reconstruction of Epistemology* (2009), *Putting Philosophy to Work: Inquiry and Its Place in Culture* (2008), and *Defending Science-Within Reason: Between Scientism and Cynicism* (2007). Professor Haack is also editor (with Robert Lane) of *Pragmatism, Old and New: Selected Writings* (2006).

**Stephen Hetherington** is Professor of Philosophy at the University of New South Wales, Australia. His main interests are in epistemology and metaphysics. He has published on many aspects of epistemology, including scepticism, the Gettier problem and defining knowledge, justification, non-absolute knowledge, induction, fallibilism, contextualism, knowledge-how, and meta-epistemology. His books include *Yes, But How do you Know? Introducing Philosophy Through Sceptical Ideas* (2009), *Self-Knowledge: Beginning Philosophy Right Here and Now* (2007), *Reality? Knowledge? Philosophy!: An Introduction to Metaphysics and Epistemology* (2003), and *Good Knowledge, Bad Knowledge: On Two Dogmas of Epistemology* (2001).

**Christian Möckel** is Professor at the Institute for Philosophy, Humboldt University, Berlin and, since 2008, Ernst-Cassirer Professor at the Department for Philosophy, University of Hamburg. His academic interests include Ernst Cassirer's work, Husserl's phenomenology, political philosophy of the 17<sup>th</sup> century and the relationship between Life and Reason in its multiple philosophical aspects. His books include *Phänomenologie. Probleme, Bezüge, Interpretationen* (2003), *Das Urphänomen des Leben. Der Lebensbegriff Ernst Cassirers* (Cassirer-Forschungen, 12), *Einführung in die transzendente Phänomenologie* (1998) and the editorial work for the *Ernst Cassirer. Nachgelassene Manuskripte und Texte*, at Felix Meiner Verlag.

**Shahid Rahman** is Professor of Logic and Epistemology at Université Lille 3 (France) and Member of the Argentinian Academy of Sciences. He is co-editor

of the Series: *Logic, Epistemology and the Unity of Science* (Kluwer-Springer Editions), *Cahiers de logique et d'epistemologie* and *Cuadernos de logica, epistemologia y lenguaje* (College Publications/Université de Lille 3). He published many studies and chapters in books in the fields of logic, epistemology and philosophy of science.

**Nicholas Rescher** is Distinguished University Professor of Philosophy and Chairman of the Center for Philosophy of Science at University of Pittsburgh. He has written extensively on a wide range of philosophical topics, including logic, epistemology, the philosophy of science, metaphysics, and the philosophy of value. His most recent books in epistemology include *Ignorance: On the Wider Implications of Deficient Knowledge* (2009), *Unknowable Facts* (2009), *Error: On Our Predicament When Things Go Wrong* (2007), and *Epistemetrics* (2006).

**Daniel Șandru** is Reader at the Faculty of Political and Administrative Sciences at “Petre Andrei” University of Iași, where he also holds the position of Director of the Department of International and Public Relations.
