Jeffrey Bloechl is associate professor of philosophy at the College of the Holy Cross in Worcester, Massachusetts. He has written, edited and translated widely in the fields of contemporary European philosophy and philosophy of religion including, as author, *Liturgy of the Neighbor: Emmanuel Levinas and the Religion of Responsibility* (Duquesne University Press, 2000). He is the founding series editor of *Levinas Studies: An Annual Review*, of which this is the first volume.

Rodolphe Calin has taught at the Université de Paris I. Sorbonne and currently teaches at a lycee in Paris. He is the author of *Vocabulaire de Levinas* (Ellipse, 2002) and *Levinas et l'exception du soi* (Presses Universitaires de France, 2005).

Richard A. Cohen is the Isaac Swift Distinguished Professor of Judaic Studies at the University of North Carolina-Charlotte, where he has also founded the Levinas Center, a major archive of primary and secondary works. In addition to several important English translations of Levinas's texts, his publications include *Elevations: The Height of the Good in Rosenzweig and Levinas* (University of Chicago Press, 1994) and *Ethics, Exegesis and Philosophy: Interpretation After Levinas* (Cambridge University Press, 2001).

Kevin Hart is Notre Dame Professor of English and concurrent professor of philosophy at the University of Notre Dame where he serves on the editorial committee of *Religion and Literature*. Recent publications include *The Dark Gaze: Maurice Blanchot and the Sacred* (University of Chicago Press, 2004), *Postmodernism* (Oneworld Publications, 2004) and *The Experience of God* (Fordham University Press, 2005), coedited with Barbara Wall.

Jeffrey L. Kosky is assistant professor of religion at Washington and Lee University. He has written and translated widely in the areas of philosophy of religion and contemporary European thought including, as author, *Levinas and the Philosophy of Religion* (Indiana University Press, 2001).

Ze'ev Levy is professor emeritus of philosophy at Haifa University, Israel. He has published books in German, English and Hebrew on a wide range of Jewish thinkers, from Spinoza to Levinas, including (in Hebrew) *Otherness and Responsibility: A Study of the Philosophy of Emmanuel Levinas* (Marges Press, 1997).

Jean-Luc Marion is professor of philosophy at the Université de Paris I. Sorbonne and John Nuveen Professor of the Philosophy of Religion at the University of Chicago. He has long been a leading authority on modern philosophy, especially Descartes, a prominent interpreter of phenomenology from Husserl through Levinas, and an influential philosopher of religion in his own right. Recent publications include *Being Given: Toward a Phenomenology of Givenness* (Stanford University Press, 2002), *Le Phénomène érotique* (Grasset, 2003), and *In Excess: Studies in Saturated Phenomena* (Fordham University Press, 2004).

Paola Marrati is professor of philosophy and has a joint appointment in the Humanities Center at Johns Hopkins University. She has published widely on themes in modern and contemporary French thought, phenomenology and aesthetics. Recent works include *Genesis and Trace: Derrida Reading Husserl and Heidegger* (Stanford University Press, 2005; originally in French, 1998) and *Gilles Deleuze: Cinéma et philosophie* (Presses Universitaires de France, 2003).

Michael L. Morgan is Chancellor's Professor of Philosophy and Jewish Studies at Indiana University. He is the author or editor of more than ten books in the areas of ancient Greek, modern and contemporary philosophy, as well as on key themes and figures in Jewish thought: Spinoza, Mendelssohn, Buber, Rosenzweig and Fackenheim. Recent works include *Interim Judaism: Jewish Thought in a Century of Crisis*

(Indiana University Press, 2001) and *Beyond Auschwitz: Post-Holocaust Thought in America* (Oxford University Press, 2001).

Alan Udoff is professor of philosophy and religious studies at St. Francis College, Brooklyn, New York, and was previously Louis Kaplan Professor of Philosophy at Baltimore Hebrew University. His numerous publications in medieval and contemporary Jewish thought include essays and edited volumes on Leo Strauss, Kafka and Rosenzweig, as well as recent work on Jean Améry, Primo Levi and Emmanuel Levinas.
