## **ELECTRONIC PUBLICATIONS—LICENSE AGREEMENT FOR INSTITUTIONAL SUBSCRIBER**

By purchasing a subscription to an electronic publication hosted on Philosophy Documentation Center's website, the Subscribing Institution accepts the Terms and Conditions set out in this document. All reasonable efforts should be made to ensure that Authorized Users at the Subscribing Institution are aware of, and abide by, these conditions. Philosophy Documentation Center reserves the right to amend these Terms and Conditions, however, no modification or claimed waiver of any provision shall be valid except by written amendment signed by authorized representatives of the Subscribing Institution and Philosophy Documentation Center.

## **PROTECTION OF PUBLICATIONS ON THIS SITE**

Philosophy Documentation Center's website contains Licensed Material owned by or licensed to the Philosophy Documentation Center, including but not limited to the content, title, and layout of each publication. These materials are protected by intellectual property laws including, without restriction, copyright, trademarks, and database rights, that Philosophy Documentation Center has agreed to protect on behalf of each publication. This commitment requires Philosophy Documentation Center to place certain restrictions on access and use of the Licensed Material.

Authorized Users at the Subscribing Institution may use the materials provided on this site ONLY for the purposes expressly permitted below. Any other use of these materials, including but not limited to any unpermitted re-distribution or re-publication in any print or electronic format, is prohibited without prior written permission from the relevant intellectual-property rights owner or the Philosophy Documentation Center.

## **RIGHTS AND RESPONSIBILITIES OF INSTITUTIONAL SUBSCRIBER**

A subscription to Licensed Material on this website grants an unlimited number of simultaneous users access to all available issues of that title for educational, research, and personal use by the faculty, staff, students, alumni, library patrons, and other Authorized Users of the Subscriber's campus/institutional network. Distance learners, alumni, and other off-campus affiliates may access the electronic publication on this website if their Internet access is through the campus network or via a secure proxy server.

Institutional subscribers are expected to make their best feasible efforts to enable access to the Licensed Material only to faculty, students, staff, alumni, and walk-in library patrons using the campus's physical library facilities.

## **THE SUBSCRIBING INSTITUTION AND ITS AUTHORIZED USERS MAY:**

view, download, copy, and save to hard disk SINGLE COPIES of portions of the electronic version of a publication to which the institution has subscribed. For reference purposes, 10% of a journal issue would be considered to be an acceptable "portion"

store for editing or temporary storage only, or print out SINGLE COPIES of individual search results; or SINGLE COPIES of individual articles (NOT ENTIRE ISSUES OF JOURNALS) for personal use, scholarly, educational, or scientific research or study, as governed by United States Copyright Law.

send one copy of any item in the Licensed Material by e-mail, hard copy, or fax to one person in the subscriber's campus/institutional network at another location for that individual's personal OFFLINE scholarly use. Under no circumstances shall such personal use include the posting of any item from the electronic publication to any personal website.

distribute a copy of individual items from the Licensed Material in print or electronic form to Authorized Users, including the distribution of a copy for noncommercial educational purposes to each individual student (Authorized User) in a class at a Subscriber's institution.

use a persistent URL, or durable URL, to the Licensed Material, including full-text articles, for courses of instruction offered by the Subscribing Institution, where access is restricted to students enrolled in the course, to instructors, and to library staff maintaining the link, and such access is limited to the duration of the course. Each item should carry an appropriate acknowledgment of the source, copyright, and publisher, and the links to such items shall be deleted by the Subscriber when they are no longer required for such purpose.

place selected listings and notices on the campus network to inform users of availability of the Licensed Material.

display, download, or print portions of the Licensed Material for the purpose of internal marketing or testing or for training of Authorized Users or groups of Authorized Users.

#### **THE SUBSCRIBING INSTITUTION AND ITS AUTHORIZED USERS MAY NOT:**

use robots or intelligent agents to access, search, and/or systematically download any portion of the Licensed Material.

transmit, disseminate, or otherwise make the Licensed Material or any components thereof available to any persons or entities who have not been authorized by Philosophy Documentation Center to use and access the site.

disassemble, decompile, or in any way attempt to reverse engineer any content or software provided on this site.

make ANY commercial use of ANY content on this site without the express written and prior permission of Philosophy Documentation Center.

#### **INTERLIBRARY LOAN**

Institutions may make copies of single documents from the Licensed Material for the purpose of inter-library loan, with the same limitations that apply to copies for that purpose made from traditional print editions. Specifically, copies must be made in compliance with Section 108 of the U.S. Copyright Act and be within the CONTU guidelines. Authorized Users who print items from the Licensed Material must maintain any copyright and other notices on the printed items. In addition, the Institutional Subscriber may, using secure means fill inter-library loan requests for limited portions of the Licensed Material using software such as Ariel, Odyssey, ILLiad, and/or some other secure transmission system.

#### **COPYRIGHT AND PERMISSIONS**

Unless otherwise noted, the publishers of the Licensed Materials hold the copyright, both as a compilation and as individual articles, on all journals, series, or other materials available on Philosophy Documentation Center's website. In the event of a dispute between a publisher and any contributor with respect to the electronic distribution of any article or other item on Philosophy Documentation Center's website, Philosophy

Documentation Center shall have the right to remove such items from the Licensed Material, and will do so upon the publisher's request.

## **ACCESS AND AUTHENTICATION**

Philosophy Documentation Center's file server permits authorized entry by recognizing the authorized IP addresses. Distance learners and alumni who access the Internet via campus IP accounts or a secure proxy server may use Philosophy Documentation Center's website, but access is not available through independent service providers. At the time the order is placed, the Subscriber provides IP addresses for the computers that require access to the electronic database. No credit is given for the submission of incorrect or incomplete IP ranges, or for IP information submitted late.

Philosophy Documentation Center will make the Licensed Material available to the Subscriber and its Authorized Users on a twenty-four hour basis, except for routine maintenance (which will be scheduled in advance whenever possible) and will restore access to the Licensed Material as soon as possible in the event of an interruption or suspension of service.

The Institutional Subscriber will make reasonable efforts to create and maintain appropriate security measures to ensure that only Authorized Users can access Licensed Material online. The Institutional Subscriber also affirms that all IP addresses provided for use of online Journals are controlled by its institution exclusively for Internet access by Authorized Users. Valid IP addresses must not include those of publicly accessible proxy or cache servers.

## **USER PRIVACY**

To maintain and improve this electronic service, and to protect each publication included on the site, Philosophy Documentation Center monitors all use of its website. Philosophy Documentation Center agrees not to share information about Authorized Users with any third parties, for any reason, except as required by a court of appropriate jurisdiction.

## **ARCHIVING OF CURRENT CONTENT / POST-CANCELLATION ACCESS**

Approximately 90 days after the expiration of an annual subscription term for full text content, Philosophy Documentation Center can provide, upon request, an archival (non-searchable) file on **DVD-ROM** or other appropriate media as determined by Philosophy Documentation Center, containing the content of all current issues of the Licensed Material published online during the 12-month subscription term. The cost of providing this archival file shall be paid by the Subscribing Institution. This archiving provision does not apply to discontinued journals or series provided on this website, or to collections of back issues or volumes of continuing publications.

Philosophy Documentation Center has also arranged for post-cancellation access to current content through **PORTICO**. This arrangement is subject to permission from the publishers of the Licensed Material on our site. Philosophy Documentation Center is working to secure the necessary permission from each publisher.

## **SUBSCRIPTION ACTIVATION AND RENEWAL**

For online access to the Licensed Material to be enabled, the Subscribing Institution must provide Philosophy Documentation Center with necessary technical and administrative data about its campus or institution network. Any changes by the Subscribing Institution to this information during the subscription period to the Licensed Material must be communicated to Philosophy Documentation Center to ensure continuity of service.

Before the end of September each calendar year Philosophy Documentation Center will provide the Subscribing Institution with pricing information for the following year. Before the end of December, Philosophy

Documentation Center will notify the Subscribing Institution regarding renewal for the following year. Renewal orders must be paid in full within 30 days of the end of a calendar year to ensure the Subscriber Institution's continued access to the Licensed Material.

**ADDITIONAL TERMS**

If any provision or provisions of this License shall be held to be invalid, illegal, unenforceable, or in conflict with the law of any jurisdiction, the validity, legality, and enforceability of the remaining provisions shall not be in any way affected or impaired thereby.

Philosophy Documentation Center will not be held liable for any delays, inaccuracies, errors, or omissions in the Licensed Materials or on its website, in the transmission or delivery of all or any part thereof, or for any damages arising from any of the foregoing. Philosophy Documentation Center does not represent or endorse the accuracy or reliability of any content.

**TERM AND TERMINATION**

These terms and conditions remain effective for as long as the Subscribing Institution continues to subscribe to the Licensed Materials.

Philosophy Documentation Center reserves the right to terminate this Agreement if (a) Philosophy Documentation Center's server logs show that the Subscribing Institution's Authorized Users have systematically violated this Agreement; (b) Philosophy Documentation Center believes in good faith that the conduct of the Subscribing Institution's Authorized Users violate or may violate applicable law; or (c) Philosophy Documentation Center believes in good faith that the conduct of the Subscribing Institution's Authorized Users is harmful to the interests of Philosophy Documentation Center, the publications on this site, other subscribers, or other users.

Philosophy Documentation Center shall provide appropriate notice to the Subscribing Institution of any violation of this agreement by the Institution's Authorized Users, in a good faith effort to resolve the problem. If said violation by the Subscribing Institution cannot be resolved, Philosophy Documentation Center has the right to terminate the subscription and the Subscribing Institution's access to the Licensed Materials. **ADDENDUM FOR INSTITUTIONAL SUBSCRIPTIONS TO ELECTRONIC DATABASE**
