## Publication Agreement

In consideration of the **Open Access publication** of the Author's manuscript (the "Manuscript") in ***The Journal of Philosophy of Disability*** (the "Journal"), the Author hereby assigns and transfers to the Journal certain copyright and other intellectual property rights in the Manuscript as follows

- a) for the first publication of the Manuscript in the Journal in any medium including but not limited to online, database, DVD, microform, print, and all forms of electronic publication, storage, and/or transmission. The Journal holds copyright to the entire content of the Journal as a collected work.
- b) for the publication of the Manuscript in all future reprints and versions of the Journal, in any medium including but not limited to online, database, DVD, microform, print, and all forms of electronic publication, storage, and/or transmission.

After the Manuscript has been published in the Journal, the Author may republish the content of the original Manuscript in any language, in any format, and for any purpose in which the Manuscript is made available for use without charge. The Author is also free to publish revised and/or longer works derived from this Manuscript in any other publication the Author might write or edit.
